   Official transcripts from schools attended in the United States must be sent directly to the Office of Admission as part of the admission process.
   a. First-year undergraduate applicants must request official transcripts from all secondary and/or post-secondary schools.
   b. Transfer and graduate applicants must request official transcripts from all post-secondary schools.
- ☐ Specific official certified evaluations of all academic transcripts of high school and college-level credit from schools attended outside of the United States must be evaluated by a NACES member evaluator. All evaluations must be sent directly to the Office of Admission by one of the companies noted below.
  - » High School: transcripts must be a general evaluation that verifies the transcripts with GPA.
  - >> Transfer and graduate students: transcript evaluations type must be a Course-by-Course Evaluation with original and/or authenticated education documents.

	<b>Form I-20</b> confirms that the applicant has been admitted to a full-time program of study at Aurora University. This form is required when the applicant applies for an F-1 student visa.
